JOB SUMMARY

The EMS Director is a managerial position that oversees, directs and manages the Emergency Medical Services (EMS) for the City of Berlin. The Director is responsible for ensuring that the City of Berlin EMS continually provides consistent, prompt, professional and effective emergency medical services to its service area. The Director supervises and coordinates the daily operations and personnel of the EMS organization. This position may require working weekends, nights and or holidays as needed to benefit the Berlin EMS. The Director must have a minimum of 5 years supervisory/administrative experience as well as hold a current Driver's License & Paramedic license with the State of Wisconsin with 5 years of paramedic experience.

ESSENTIAL JOB FUNCTIONS

- 1. Responsible to the city for the efficiency and general good conduct of the ambulance service and ambulance personnel.
- 2. Responsible for all property and equipment belonging to the ambulance service.
- 3. Shall be available 24 hours a day, 7 days a week via pager. In his absence, he will ensure that the assistant director or the Directors appointee is left in charge.
- 4. Responsible for submitting an annual budget and following the approved annual budget during the fiscal year.
- 5. Conduct regular meetings for the management team and monthly business/training meetings for Berlin EMS personnel.
- 6. Review QI/QA reports from the resource managers for the purpose of quality improvement in conjunction with the medical director.
- 7. Regularly meet and communicate with City Clerk, City Council or its agent as needed.
- 8. Maintain communication with other emergency and ancillary services in the community and county as well as participate in Fox Valley Regional Trauma

- Advisory Committee and any other regional or state organizations which would benefit Berlin EMS.
- 9. Develop, maintain and implement all policies and procedures to be followed by EMS Personnel.
- 10. Oversee procurement of all EMS related purchases, along with timely processing all invoices and providing receipts for every purchase.
- 11. Accurate processing and submission of biweekly EMS payroll to the City Clerk.
- 12. Ensure ambulance billing service receives all pertinent and accurate run and patient data timely and ensure that proper and timely billing practices and procedures are followed by the billing service.
- 13. Fill unassigned shifts as needed to make sure 24/7 coverage. This may require working weekends and holidays as necessary.
- 14. Seek additional funding for City of Berlin EMS through grant application opportunities.
- 15. Positively promote Berlin EMS within the community, provide educational programs and speaking engagements.
- 16. Maintain residency within 15 miles of the City of Berlin.
- 17. Maintain Compliance with Wisconsin Statute 256 and Administrative DHS 110. This includes ensuring all elements of the EMS operation plan are kept current, the organization's State licensing, E-Licensing, and EMS personnel licensing and credentialing are current.
- 18. Any other duties as assigned or necessary for the service.

BEHAVIOR AND ATTITUDE

The mission philosophy of Berlin Emergency Medical Service requires this position to be performed in both a professional and personable manner. The manner in which the employee relates to fellow employees and patients is considered equal in importance to technical knowledge and ability. Respect and consideration given to the dignity of each patient and fellow employees is a requisite of successful job performance. In addition, confidentiality of the City's business must be maintained and all HIPPA law requirements adhered to.

PHYSICAL & OTHER DEMANDS

- 1. Ability to occasionally lift and carry heavy objects of 20-50 lbs.
- 2. Ability to sit continuously for long periods of time, and occasionally reach above shoulders and bend.
- 3. While performing the duties of this job, the employee is frequently required to talk or hear; use hands to finger, handle, feel or operate objects, tools, or controls; and reach with hands and arms. The employee is frequently required to stand and walk.

- 4. Eye-hand coordination is necessary to operate various pieces of equipment.
- 5. Task involves the regular, and at times sustained, performance of heavier physical tasks such as walking over rough or uneven surfaces, bending, stooping, working in confined spaces, and lifting or carrying moderately heavy (20-50 lbs.) items.
- 6. For the majority of tasks the work is performed in a controlled office environment. There are however exposures to adverse environmental conditions during emergency activities.

Re: Ambulance Fee Schedule

Council Members and City Administrator:

I have been in close contact with Joel Kent, who does our ambulance billing with Cvikota Billing. Over this past year we have seen some dramatic increases in expendables, including, but not limited to, the cost of medications.

There are many reasons for this. One reason is a shortage in medications. The last few hurricanes were very destructive, and many medications were diverted to those that were hardest hit. Examples include Normal Saline, which is our IV fluid, pain medications, such as Morphine, diabetic medications, such as Dextrose and antibiotics. All medications were affected, and as such the State EMS Department has worked with the FDA to increase the expiration dates on some of our more common medications. However, once used, they are also the hardest to replace. Another reason for an increase is supply and demand. Narcan, the drug used for narcotic overdose, is in great demand and has a limited supply. These reasons, and others, have generated an increase in our costs.

It is the recommendation from our billing company that we increase our costs to the patients as to offset the increase we have seen. The other recommendation was to increase our mileage charge and our ALS2 base rate, to be more in line with other EMS Agencies in our area. Finally, the recommendation is to make a complete cost increase of 5% starting January 1, 2017. He makes this recommendation to all his clients, stating that way there is no sudden increase after 2-3 years of no change.

I recommend that we adopt his proposal and go with the fee schedule increase he has proposed.

PROPOSED REVISIONS TO WEIGHTS AND MEASURES FEE SCHEDULE

Base rates for Appleton Health Department Environmental Health and Weights & Measures fees were established in an independent Study authorized and funded by the Common Council in 1993. The final report was referred to as the Griffith Study.

Annually since 1993 we have evaluated the actual cost of services provided, reviewed our current fees for those services rendered, and made recommendations for increases where justified. The Board of Health has acted upon and approved these recommendations when submitted.

In recent years we have used the federally established and nationally recognized Consumer Price Index (CPI) as the factor in determining appropriate fee increases.

In 2003 we did an exhaustive study of the Weights and Measures Section to evaluate feasibility and costs of contracting with several area municipalities. From this study and with the assistance of John Hoft-March of our Finance Department, we recalculated our actual operating cost for operations within the City of Appleton. These figures are now updated annually.

Our device license fee rates are based upon the standardized, average amount of time spent to inspect, test and certify a device times the current operating cost per hour. With the new hourly rate and with special consideration to each fee I have developed the new Recommended Fees shown. Weights and Measures fees are calculated to the nearest whole dollar amount.

With the rate changes submitted we estimate a revenue increase of \$218.

A RESOLUTION TO MEMORIALIZE AND CONFIRM THE UNDERSTANDING BETWEEN THE BOYS & GIRLS CLUB OF THE TRI-COUNTY AREA AND THE CITY OF BERLIN ON THE CONSTRUCTION, DEDICATION, AND FUTURE MAINTENANCE & RESPONSIBILITY OF A BUS SHELTER ON S. WASHINGTON STREET RIGHT-OF-WAY

WHEREAS the Boys & Girls Club of the Tri-County Area ("BGC) did come before the Common Council on April 4, 2017 proposing to provide shelter for area children waiting for buses, by constructing a bus shelter in the City of Berlin ("CITY") right-of-way along S. Washington Street terrace area; and

WHEREAS the BGC proposed that the bus shelter would be constructed at no cost to the CITY; and

WHEREAS the BGC proposed that all future routine and non-routine maintenance responsibilities and associated costs would be the responsibility of the BGC. This would include structural or condition repairs, clean-up or repairs from vandalism, maintaining appearance and cleanliness, keeping in safe and usable condition for the public, snow shoveling, removing garbage, etc; and

WHEREAS the BGC proposed to dedicate the completed bus shelter structure to the CITY:

NOW THEREFORE BE IT RESOLVED that based on the above the City of Berlin Common Council hereby:

- 1. Will allow the Street Superintendent to work with the BGC to construct a mutually agreed upon shelter in the terrace area of S. Washington Street as it has public benefit.
- 2. Upon satisfactory completion of the shelter, as determined by the Street Superintendent, will accept the dedication of the bus structure from the BGC.
- 3. Recognizes and understands that all future maintenance or repairs and related costs for the structure will be the responsibility of the BGC. The BGC will routinely inspect and maintain the overall condition and appearance at all times in the future, with all concerns being addressed in a timely manner.

RESOLUTION #17-09

A RESOLUTION DETERMINING THAT A PUBLIC EMERGENCY EXISTS IN REGARD TO THE 107 W. HURON STREET PROPERTY BIDDING PROCEDURES FOR REPAIRS

WHEREAS, the Common Council has previously authorized the commencement of bidding procedures for repair work to be conducted at the property located at 107 W. Huron Street in the City of Berlin, pending and conditioned upon the City's acquisition of such property; and

WHEREAS, normal bidding procedures as required by Wis. Stat. §62.15 would cause significant delays in the commencement of the repair work necessary to correct the building deficiencies at such property; and

WHEREAS, the deficiencies at the 107 W. Huron Street property include an unstable roof, water leakage, rodent infestation, and other issues, all of which present an immediate endangerment to the public's health and welfare, and such issues will only be exacerbated by snow falling on the property; and

WHEREAS, pursuant to Wis. Stat. §62.15(1b), compliance with the public bidding requirements of Wis. Stat. §62.15(1) are not mandatory for the repair and reconstruction of public facilities when damage or threatened damage thereto creates an emergency, as determined by the Board of Public Works, in which the public health or welfare of the City is endangered; and

WHEREAS, the City of Berlin does not have a Board of Public Works; the statutory duties and powers of which are exercised by the Common Council.

NOW, THEREFORE, BE IT RESOLVED, as follows:

- 1. The deficiencies at the 107 W. Huron Street property, as described in the recitals above, constitute an emergency in which the public's health and welfare is endangered. Accordingly, the bidding requirements set forth Wis. Stat. §62.15(1) is not mandatory, and the following bidding procedures shall be used for this project:
 - a. City staff in cooperation with Kunkel Engineering Group shall send out at least six (6) Requests For Proposals to reputable contractors that are suitable for performing the repairs needed at 107 W. Huron St property.
 - b. A scope of the project shall also be posted on the City website.

- c. Publication in the newspaper shall not be required.
- 2. For clarity, the City of Berlin does not have a Board of Public Works, and, pursuant to Wis. Stat. §62.14(1), the Common Council exercises all statutory duties and powers of the Board of Public Works, including but not limited to the authority to adopt this Resolution.
