The Wisconsin Department of Revenue would like to inform you of the <u>2017 Wisconsin Act 68</u> (AB 480) that was published on November 28, 2017, and how it impacts property assessment.

The following provides a summary of the changes. The 2018 Wisconsin Property Assessment Manual (WPAM) will provide additional details.

### **Summary of Changes**

- Amended 70.05 (4m) assessor property access
  - Property owner may deny assessor interior entry
  - o Denial to enter interior shall not prevent owner from appearing at Board of Review (BOR) to object
  - o Assessor may not increase the value solely on the property owner's refusal to allow entry
- Created 70.05 (4n) assessor property access
  - o If requesting view of interior, assessor shall provide written notice that includes property owner rights
  - Statute provides notice language assessor must provide:

#### PROPERTY OWNER RIGHTS

You have the right to refuse entry into your residence pursuant to section 70.05 (4m) of the Wisconsin Statutes. Entry to view your property is prohibited unless voluntarily authorized by you. Pursuant to section 70.05 (4m) of the Wisconsin statutes, you have the right to refuse a visual inspection of the interior of your residence and your refusal to allow an interior inspection of your residence will not be used as the sole reason for increasing your property tax assessment. Refusing entry to your residence also does not prohibit you from objecting to your assessment pursuant to section 70.47 (7) of the Wisconsin statutes. Please indicate your consent or refusal to allow an interior visual inspection of your residence.

- Amended 70.47(1) Board of Review Time and Place of Meeting
  - o Current law meet annually during 30-day period starting 2nd Monday of May
  - o New law meet annually during 45-day period starting 4th Monday of April, no sooner than seven days after the last day which the assessment roll is open for examination under 70.45
- Amended 70.47(7)(aa) Board of Review Appearances
  - o No person can appeal to the BOR if refused reasonable written request of assessor to view exterior of property
- Amended 70.47(7)(af) Board of Review and Property Appealed Using the Income Method to Value
  - No person can appeal to the BOR if the value was made by assessor using the income method unless no later than seven days before the first meeting of the BOR, the person supplies to the assessor all information about income and expenses
  - Information provided under this paragraph is not subject to right of inspection and copying unless a court determines before the first meeting of the BOR that information is inaccurate

### **Request to View Property Process**

2017 Act 68 requires the assessor to provide property owners with written notice if requesting an interior view:

1. Send state prescribed letter\* for properties requiring view through regular mail. It is a best practice to send whether an interior or exterior view or both are required. Allow 14 calendar days to respond.

- \*NOTE: DOR is posting the new state prescribed letter with the 2018 WPAM. Assessors may use a different version when approved by DOR.
- 2. For property owners who do not respond, consent or denial may be obtained in person. If the property owner is unavailable, leave a door hanger with contact information.
- 3. For remaining unresponsive property owners, send the state prescribed letter via certified mail. Allow 14 calendar days to respond.
- 4. If property owners do not respond with an affirmative consent or denial to the request for view, the following options are available:
  - Consider using the next best information available (see 2018 WPAM Chapter 9) to establish a supportable valuation
  - Use the special inspection warrant (see 2018 WPAM Appendix for warrant template) to gain view if next best information is insufficient to develop a supportable valuation
  - o Note the lack of response at the BOR, if applicable

### **Board of Review - Recommended Practice**

2017 Act 68 allows the BOR to deny a hearing to a property owner who does not allow the assessor to complete an exterior view. However, the Wisconsin Supreme Court expressed due process concerns regarding a similarly worded statute in *Milewski v. Town of Dover*, 2017 WI 79, 377 Wis. 2d 38, 899 N.W.2d 303. It is DOR's recommendation to allow a BOR hearing even if the property owner denied an interior or exterior view. The lack of access to view, and the credibility of evidence offered can be managed as an evidentiary issue at a BOR hearing, rather than denying access to the BOR.

CONTRACT

NOW THEREFORE, IT IS AGREED AS FOLLOWS:

### 1. HOURS OF OPERATION

Classic Cab agrees to operate a taxi service within the City of Berlin and the surrounding 5-mile radius for the year 2018 during the following hours:

- (a) Monday through Friday 7:30 A.M. to 5:30 P.M.
- (b) Saturday 7:30 A.M. to 5:30 P.M.
- (c) Sunday 7:30 A.M. to 3:00 P.M.
- (d) Major holidays by appointment (New Year's, Easter, Memorial Day, Fourth of July, Labor Day, Thanksgiving, Christmas.)
- (e) Cab service will operate approximately one-half hour each morning Monday through Friday on reservation basis only, before the 7:30 start time.
- (f) Services outside the scheduled hours by 12-hour advance reservation only.
- (g) Modifications to said hours may be made, but said modifications must be submitted in writing to the City and the Wisconsin Department of Transportation for approval prior to any change going into effect.
- (h) After hour services may be provided by appointment.

### 2. FARE SCHEDULE

The fare structure for the year shall be as follows:

Adult: \$2.503.00

Additional Passengers: \$.75 per passenger - excluding children under  $\frac{10 - 5}{2}$  accompanied by adult.

Additional charge of  $\frac{1.00}{51.50}$ per mile outside of City Limits.

Senior Citizens: \$1.502.00, \$.75 extra passenger

School Rides: \$1.502.00 all school ages

Modifications to the fares may be made, but said modifications must be submitted to the City and the Wisconsin Department of Transportation for approval prior to any fare change going into effect.

### 3. CLASSIC CAB TO MAINTAIN RECORDS

Classic Cab will establish and maintain accounting procedures and documentation as required by the City. Documentation will include, but need not be limited to, hours of employment, wages, expenses, number of passengers, and fares collected. Classic Cab shall also complete in draft form, the necessary reports the City shall be required to furnish the State Department of Transportation.

### 4. FILING OF REPORTS

The City agrees to file the necessary quarterly reports within 10 business days after Classic Cab files its quarterly report with the City.

### 5. LIMITATION ON CITY PAYMENT

It is agreed between the parties that the City of Berlin shall pay any operating deficit not covered by the State of Wisconsin or the Federal Government.

### 6. PAYMENT OF MONTHLY DEFICIT

The City of Berlin shall reimburse Classic Cab for the Contract Expenditures in excess of Passenger revenues by the 10th of the following month.

### 7. TERM OF AGREEMENT

This agreement shall terminate December 31, 2018, but may be extended for additional one-year periods upon agreement of both parties.

### 8. OPERATION IN ACCORDANCE WITH GRANT

Classic Cab will operate the system in accordance with the provisions of the 2015 state operating assistance contract.

### 9. SALARIES

Classic Cab will not increase officer's salaries over the rates shown in grant, without the approval of the Berlin Common Council and the Department of Transportation.

### 10. DRUG CONTROL PROGRAM

The operator will initiate a drug control program in

accordance with applicable federal regulations.

### 11. DISABILITY REQUIREMENTS

The operator will assist the City in complying with requirements of the Americans with Disabilities Act (ADA).

### 12. INSURANCE

The operator will maintain appropriate insurance coverage as outlined in the Request for Proposals from Qualified Shared-ride Taxi providers dated December 13, 2013.

### 13. THE CITY OF BERLIN AGREES TO:

- (1) Review and approve monthly statements.
- (2) Issue a subsidy check on a regular monthly basis.
- (3) Accept the Wisconsin Department of Transportation's determination of total operating deficit.
- (4) Pay the portion of the total operating deficit not paid By the Federal Department of Transportation and/or the Wisconsin Department of Transportation.
