### Indemnification, Defense, and Hold Harmless Agreement for Brush Truck(s)

The undersigned understands that the loading and/or use of said truck(s) may entail some risk, including property damage, personal injury, and even death, and that the undersigned agrees to assume such risk. The undersigned further acknowledges that no City of Berlin personnel will be supervising the undersigned's use of said truck(s), nor has any City of Berlin personnel been requested to supervise. The undersigned acknowledges that no training or instructions for the loading of said truck(s) has been provided by the City of Berlin, and the undersigned represents that he or she knows how to safely load the truck(s) provided hereunder. The undersigned represents and agrees to use the truck(s) provided by the City of Berlin only for the purposes intended, which is to load brush and tree branches and other allowable vegetation as authorized by the Superintendent of Streets. The undersigned agrees that he or she will not have access to the cab of the truck(s) and is to make no attempt to operate the truck(s).
