#### New Business:

A) ABC Group requests permission for Christmas tree and reindeer at Nathan Strong Park - discussion and action as appropriate.

Discussion revolved around raising the campground rates from \$20.00 to \$25.00 per night fees and \$120.00 to 150.00 weekly fees due to the installation of the new showers facilities and updated electrical, to bring prices in lie with surrounding areas.
