## CITIZEN PARTICIPATION PLAN FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM CITY OF BERLIN

#### **PURPOSE**

For the CDBG Program to operate effectively, and to address the needs of the citizens of the City of Berlin, the entire population must be kept informed. The decision-making process must be open and consistent with State and Federal regulations. To accomplish this, the following plan will be followed:

#### PROGRAM OVERSIGHT

- The City of Berlin shall create a Citizen Participation Plan Committee. All members of the City of Berlin's Common Council will also serve as Citizen Participation Plan Committee members. This Committee shall be responsible for implementation of the Citizen Participation Plan, as well as offer guidance in preparation of the grant application.
  - The City of Berlin City Administrator shall oversee the preparation of the Community Development Block Grant (CDBG) grant application.
- 2. To ensure responsiveness to the needs of its citizens, the City of Berlin shall provide for and encourage citizen participation with particular emphasis being given to participation by persons of low to moderate income (LMI).

#### **CITIZEN PARTICIPATION**

1. The Committee members should include representatives from the local government, real estate, banking and labor communities whenever possible. This Committee must include at least one LMI person. This Committee shall assume responsibility for coordinating all required elements of the Citizen Participation Plan. All Committee members must be residents of the City of Berlin.

#### NOTICE OF HEARINGS

1. Official notice of hearings will be via Class I notice in the City of Berlin's Official Newspaper at least two full weeks prior to the hearing. In addition, the public notice shall be posted at City Hall in the City of Berlin. These notices will include the time, place and date of meetings, as well as a brief agenda.

2. All notifications of meetings and available assistance must be worded in such a way as to encourage LMI participation. In addition, all meeting announcements shall include where, and during what time, information and records relating to the proposed and actual use of funds may be found.

#### REQUIRED PUBLIC HEARINGS

Two public hearings shall be held to obtain citizen views and to enable them to respond to proposals at all stages of the CDBG Program, including the development of needs, the review of proposed activities and the review of program performance. Hearings shall be held after adequate notice, at times and locations convenient to potential or actual beneficiaries with accommodations for the handicapped, and, if needed, for non-English speaking persons.

- 1. The first hearing will receive citizens' views and provide an explanation of:
  - a. Community development needs, objectives, and strategies.
  - b. The CDBG program including goals, objectives, application process, amount of funds available, timetable, eligible activities, etc.
- 2. The second hearing will receive citizens' input and provide a review of the performance of the funded activities.
- 3. The first public hearing shall be held during the development of the application for funds. The second public hearing shall be held during the implementation of the program. The City of Berlin will attempt to have at least one of the public hearings in the service area (if applicable).

#### PROGRAM INFORMATION, FILES, and ASSISTANCE

- Technical assistance will be provided to any citizen who requests information about CDBG program requirements. Assistance with the application process will be provided by City of Berlin staff in the Community Development Department. A City of Berlin staff member will meet with citizens on request.
- 2. The City of Berlin will maintain a record of all citizen participation efforts including minutes of meetings, newspaper clippings, and copies of notices and brochures, in the Community Development Department of City Hall.
- 3. Citizens will be invited to make proposals regarding the application. If suitable proposals are submitted in writing, a written response will be provided within 15 days. Every effort will be made to respond to all proposals prior to the final action on the subject.

4. Citizens may petition or request in writing assistance or changes. City of Berlin staff will respond to all such requests within 15 days after the City of Berlin's Citizen Participation Plan Committee has met to discuss the request.

#### COMPLAINTS

The City of Berlin will handle citizen complaints about the program in a timely manner. By federal regulation, the City will respond in writing to all written letters of complaint within 15 days after receipt of the complaint. The nature and disposition of verbal complaints will be documented in a complaint log. The first contact for complaints should be made to the City of Berlin Mayor, 108 N. Capron Street, P.O. Box 272, Berlin, WI 54923.

In addition to the above procedure, any citizen wishing to object may complain directly to the following address:

Written complaints should contain the following information and should be as specific as possible when describing:

- The Program area being referenced: HOME, Community Development Block Grants for Housing (CDBG – Housing), Community Development Block Grants for Community Development (CDBG – Community Development), Community Development Block Grant Close Program (CDBG-CL), Emergency Solutions Grants (ESG), etc.;
- 2. The event resulting in the complaint;
- 3. The dates, details, and reason for the complaint; and
- 4. The complainant's name, address, and telephone number.

#### NON-ENGLISH SPEAKING PERSONS

The City of Berlin will regularly survey the municipality to identify non-English speaking persons and will make all special efforts to assure them equal opportunity in the citizen participation process.

The amount charged for said lateral shall be based upon the Housing Task Force Standardized Special Assessment Schedule for the replacement of sewer lateral, as approved by the Common Council, based upon 2020 rates, as long as the lateral is for standard service, but shall in no case exceed 100% of the total cost of the improvements. If larger service is required, the actual cost for the installation of the lateral for said lot shall be accounted for and charged to said lot and entered on the tax roll as a special tax on said lot.

In regard to the sidewalk installation, repairs, and replacements, the Street Superintendent shall keep an accurate account of the expenses incurred in front of each lot and shall report these costs to the city clerk who shall, pursuant to city ordinance relating to sidewalk replacement, cause  $\frac{1}{2}$  of such expense for each applicable lot to be entered on the tax roll as a special tax against the lot. In no case shall the amount assessed to a lot be more than 50% of the total cost of the sidewalk improvements benefiting the lot.

- 4. The Common Council determines that the improvements constitute an exercise of the police power for the health, safety and general welfare of the City of Berlin and its inhabitants.
- 5. The City Engineer shall prepare a report which shall consist of:
  - a. Preliminary plans and specifications for the improvements.
  - b. An estimate of the entire cost of the proposed improvements.
  - c. Schedule of proposed assessments.
- 6. When the report is completed, the City Engineer shall file a copy of the report with the City Clerk for public inspection and, if state property is to be assessed, shall mail a copy of the report to the responsible state agency and, for assessments of \$50,000.00 or more, to the Wisconsin State Building Commission.
- 7. Upon receiving the report of the City Engineer, the City Clerk shall cause notice to be given stating the nature of the proposed improvements, the general boundary lines of the proposed assessment district (including a small map thereof), the time and place at which the report may be inspected, and the time and place of the public hearing on the matters contained in the preliminary resolution and the report. This notice shall be published as a Class I Notice under Chapter 985, Stats., and a copy shall be mailed, at least ten (10) days before the hearing, to every interested party whose address is known or can be ascertained with reasonable diligence.
- 8. The hearing shall be held in the City Hall Council Chambers at 108 N. Capron St., Berlin, WI 54923 at a time set by the City Clerk in accordance with Wis. Statutes §66.0703 (7).
- 9. The assessment against any parcel may be paid in cash or in annual installments, the number of which shall be determined at the public hearing on the proposed assessments.

- Webster St. (N. Washington St. to N. Kossuth St.) This section of roadway will receive a complete street and utility reconstruction, which shall include sanitary sewer, watermain, associated laterals, storm sewer, aggregate base course, curb & gutter, sidewalk patching, new asphalt pavement, and site restoration.
- S. State St. (E. Huron St. to Ripon Rd.)- This section of roadway will receive a complete street and utility reconstruction, which shall include sanitary sewer, watermain, associated laterals, storm sewer, aggregate base course, curb & gutter, sidewalk patching, new asphalt pavement and site restoration.
- S. Swetting St. (Junction St. to Ripon Rd.) No utility work is being done in this section of roadway. The existing pavement will be full depth milled and repaved, spot curb & gutter repairs and manhole adjustments.
- Jackson St. (Broadway St. to Webster St.) No utility work is being done in this section of roadway. The existing pavement will be full depth milled and repaved, spot curb & gutter repairs.
- Jefferson St. (Broadway St. to Webster St.) No utility work will be done on this section of roadway. The existing pavement will be full depth milled and repaved, spot curb & gutter repairs



it. You will be able to ask questions and gather information, as well as share any information you may have that would be pertinent to the project.

On Wednesday, March 18, 2020 from 4:30 – 6:00 p.m. City Staff and representatives of Kunkel Engineering will be available in the City Hall Council Chambers to discuss the 2020 Reconstruction and Utility Projects. We will be having a formal 15 minute presentation at 4:30 p.m. and 5:30 p.m. to go over the main points or concerns that the majority of the residents would have. The remaining time will be open for you to have an opportunity to meet with the engineers or staff to discuss your property one-on-one and answer any additional questions you may have. A project such as this will typically include a sanitary lateral assessment and a lead water service assessment to affected property owners. Driveway or sidewalk assessments may be applicable depending on your situation. Questions on potential assessment items can be answered at this meeting, but no assessment figures are available at this time. Information relating to special assessments will be provided to property owners at a later date as the project progresses.
