RE: 2020 PD Unused Funds

BACKGROUND: 2020 has been an odd year for municipal budgets, however, it was exceptionally odd for the PD due to management and other staffing changes. Staffing shortages did result in budgetary saving in salaries. There were also equipment purchases that were held off on due to the interim management situation. Although there are equipment updates necessary, the Acting Police Chief and I had agreed that some of the purchasing decisions should be made after the new Chief is in place so he/she would have input. Therefore, we did hold off on some equipment purchases, but a new Chief is not yet in place. At this point, we expect that to happen early in 2021.

As you know, I strongly believe that any unused department budgeted funds should get rolled back into the General Fund for future use at the discretion of the City Council. Allowing departments to annually carryover unused monies creates over budgeting concerns and departmental "slush funds" to develop. I believe Council should retain control of unused funds. However, I find this circumstance to be so unique that it should be given some consideration for a one time carry over for future equipment.

Due to the exceptional situation and transition that the PD was in during 2020, I am requesting Council consider allowing the carryover of unused funds for the 2020 PD budget be placed into the Capital Equipment fund (Account 15-34179) for the Police Department to be used for future equipment purchases. I do not have an exact dollar figure of what that will be yet, however, I would suspect it would be in the range of \$75-\$95k. Setting it aside in the capital fund will allow for larger purchases such as squad cars and other police related equipment. The monies would still need to be approved by Council to be expended through the budgeting process or by budget adjustment.

<u>RECOMMENDATION:</u> Recommend to Common Council to authorize the rollover of 2020 unused budgeted funds to be set aside in Fund 15 (Account 15-34179) for future Police Department capital expenditures.

FROM: Community Development Block Grant for Coronavirus (CDBG-CV) Application

In November Jodie and I submitted intent to apply for two grants through the CDBG-CV through the Department of Administration. The CDBG-CV funds have to meet CDBG national objective and be used to prevent, prepare for or respond to the Coronavirus. Jodie's intent to apply was for antibacterial light air filtration system for City Hall, Senior Center, and Library. I applied to create a microenterprise business grant program. In December the City was invited to submit the full application and notified that funds have been set aside in the amount requested and may receive if completed application is submitted. The applications are due February 26th. The application requires citizen participation public hearing. The citizen participation plan committee will need to conduct public hearing on February 9th at 6:30pm. The citizen participation plan committee is made up of all members of the Common Council.

Recommendation: Schedule public hearing for citizen participation plan committee for CDBG-CV application for antibacterial light air filtration system for City Hall, Senior Center, and Library and creation of microenterprise business grant program for February 9th at 6:30pm.
