FROM: Community Development Block Grant -Business RLF (CDBG-RLF) Funds

This past week the City finalized the buyout of the CDBG- business RLF. The buyout consisted of \$750,899.99 in accounts receivable. The accounts receivable balance is now considered de-federalized funds. The fund was created when the City applied for the funds from State to assist the Berlin Foundry with a low interest loan. Since then the funds have been revolved within the City of Berlin to assist several businesses in the community with the most recent loan to Nelson Name Plate Company when they acquired Wilson Hurd. This program is a unique tool that the City of Berlin can utilize to assist in business development and growth. Berlin is the only municipality within Green Lake, Marquette, and Waushara County that provides local low interest loans.

The Berlin Community Development Corporation (BCDC) assisted in reviewing the applications and recommended approval to the Common Council. Currently there is a zero balance in the account, due to the buyout of the program. Overtime we anticipate receiving the full \$750,000, but that will be about 20 years and could be less if a business defaults on their loan. The BCDC typically would be monthly to review the financials and other items. To reduce cost and time of the volunteers on the board, I do not see a need to meet monthly unless there is a loan request or outstanding issue with one of the loans. In the past, attorney expenses have been paid from the fund. Does the City want to continue to have attorney expenses billed separate or to include attorney expenses/hours within the City's yearly attorney contract? If there are attorney expenses directly related to a loan, the related business will pay for the attorney expenses.

Recommendation: Continue to utilize the business RLF to assist business development and growth in the City of Berlin through the BCDC and final approval by the Common Council. Request BCDC to review loan manual and recommend any proposed changes to Common Council for approval.

FROM: Community Development Block Grant for Planning (CDBG-Planning) Application

I am intending to apply for a CDBG-planning grant to update the current economic development plan. The current plan was completed in 2014 and since then the focus for economic development has shifted since that plan was completed. The grant can be up to \$50,000 with a 2:1 match. So the city's expense would be 1/3 of the overall project costs. Due to the City of Berlin being a LMI community, we will automatically meet the national objective for the grant.

Recommendation: Schedule public hearing for citizen participation plan committee for CDBG-Planning application for economic development plan for March 9th at 6:30pm.
