

Current Vacancies:

Serving on the **Cemetery Board** you would govern, manage, control, improve and care for all the city's cemetery property in an advisory capacity to the common council; allocating labor and machine work necessary to landscape and maintain the cemetery grounds in accordance with rules and regulations of the cemetery, investment and handling of cemetery accounts and funding needs for the purpose of promoting the proper designation of purpose for the funding when members of the public are considering gifting monies to the cemetery.

Serving on the **Plan Commission** you may make, adopt and, as necessary, amend, extend or add to the master plan, subject to confirmation of the common council, for the physical development of the city, the general location, character and extent of streets, highways, freeways, street grades, roadways, walks, parking areas, public places and areas, parks, parkways, playgrounds, sites for public buildings and structures, and the general location and extent of sewers, water conduits and other public utilities, whether privately or publicly owned, the acceptance, widening, narrowing, extension, relocation, removal, vacation, abandonment or change of use of any of such public ways, grounds, places, spaces, buildings, properties, utilities, routes or terminals, the general location, character and extent of community centers and neighborhood units, and a comprehensive zoning plan.

Serving on the **Parks and Recreation Commission** you shall have all of the powers conferred by law upon park and recreation commissions and shall be chargeable with all of the duties so required, such as recommend, oversee work and oversee funds of all parks, playgrounds and recreational activities as part of properties within the city. The parks and recreation commission is specifically empowered and directed to govern, manage, control, improve and care for all public parks located within, or partly within and partly without, the city, and secure the quiet, orderly and suitable use and enjoyment of such public parks by the people, and also adopt rules and regulations to promote such purposes. In the name of the city, for park purposes by gift, purchase, devise, bequest or condemnation, either absolutely or in trust, money, real or personal property or any incorporeal right or privilege. And with prior common council approval, to buy or lease lands in the name of the city for park purposes, within or without the city, and, with the approval of the common council, to sell or exchange property no longer required for its purpose.

Serving on the **Committee on Aging** you shall serve in an advisory capacity to the common council on all aging related issues, coordinate all services and facilities for the aging in order that their needs can be most effectively met, develop such new services as may be necessary to serve the aging, and upon the direction of the common council, educate the public to the potential possible for persons in their retirement years, carry on necessary research to determine the needs of older persons and to make recommendations to the common council for improved services and programs based on this research, communicate as to the funding needs of the senior center and other aging related program and subject to the authorities of the common council and city clerk-treasurer to govern, manage, control, improve and care for the city's senior center and all aging related programs.

Serving on the **Community Development Authority** you shall not assume the duties or replace the plan commission in any respect, rather, you will have sufficient ability and experience in the fields of urban renewal, community development and housing, as commissioners of the community development authority.
